- An explanation of DCTA's Access Service and how it impacts mobility needs.



# Strong Ridership Growth in FY22 and Momentum for FY23









# UNT Shuttle and Late-Night Ride Service



- DCTA has an agreement with the University of North Texas to provide shuttle service.
- DCTA currently operates 14 shuttles in and around the University.
- UNT Students may ride shuttles and Connect Bus service free of charge by showing their student ID.
- UNT Shuttles are also open to the general public.
- DCTA also offers a UNT Lyft Program providing free rides on campus to UNT students, faculty and staff between 2 a.m. to 7 a.m. along the UNT Lyft Zone.







### **DCTA Access Service**





- Access is a shared-ride, origin-to-destination service that provides transportation for disabled and elderly (65+) residents in Highland Village, Lewisville and Denton.
- Two types of eligibility:
  - Paratransit trips
    - 3 categories of eligibility based on ADA standards
    - Given priority in Access booking
  - Non- ADA qualified
    - Available to seniors 65+ and non-ADA qualified individuals with disabilities
    - Access booking first come, first serve based on availability

### Qualifying for Access ADA Paratransit Service

Please have your card accessible, and present to fare inspector or bus operator upon request.


- An application process is required for all Access services.
  - Application available by calling DCTA and on <u>www.dcta.net</u>
- Upon receipt of completed applications, ADA regulations allow a <u>maximum of 21 days</u> to process applications
  - If DCTA has not made a decision on eligibility within 21 days, the applicant may use Access ADA paratransit until a determination is made.
  - Individuals are permitted to request an appeal to the DCTA Access Appeal Panel
- A person may be determined to be eligible, temporarily eligible, or conditionally eligible for certain trips
- Individuals who are eligible for Access ADA Paratransit qualify for free fares on DCTA fixed route and GoZone service
- Passengers are required to recertify every three years from the date of their original certification

### Qualifying for Non-ADA Access Service






- DCTA applies Federal Transit Administration "Half Fare" regulations to determine eligibility for non-ADA Access Service
- To be eligible for non-ADA Access trips, individuals must be one of the following:
  - Age 65 or older;
  - A person "who by reason of illness, injury, age, congenital malfunction, or other incapacity or temporary or permanent disability (including any individual who is a wheelchair user or has semi ambulatory capabilities), cannot use effectively, without special facilities, planning, or design, mass transportation service or a mass transportation facility;"
  - Medicare cardholders
- Non-ADA Access trips are provided on a first come, first serve basis only to the extent that there is excess capacity on the system.

### Executive Summary: January 1, 2023 Service & Fare Change




On July 28, 2022, the DCTA Board of Directors approved the Service and Fare Changes

- Promotional GoZone fare of \$0.75 per trip expired
- GoZone base fare is now \$1.50 per trip
  - \$0.50 per-mile charge for trips within Denton zone greater than 4 miles
  - \$5 fare cap applicable in Denton only
  - No per-mile charge in the Lewisville/Highland Village Zone
- Eliminate GoZone passes unless riders are eligible for existing discount or non-profit pass purchase
- Reduced fare eligible passes, non-profit passes or employee passes still valid on GoZone
- Revised Connect Bus service shall be Routes 3, 6, and 7 as depicted in 'Alternative E as proposed'
- Service and Fare Changes took effect on January 1, 2023



# **Redesigning Fare Media**





### Fare Media Redesign





- DCTA accepts several different forms of fare media
- Board decision to eliminate GoZone passes
   unless customer is:
  - ADA Paratransit customer
  - Reduced Fare Eligible
  - Nonprofit Pass purchase
  - Corporate Pass purchase
- As a result, DCTA redesigned all fare media to eliminate GoZone passes for riders who are not eligible for discount
- Newly designed media labeled "Valid on GoZone" or "Not Valid on GoZone" to alleviate passenger and operator confusion
- Fare media overhaul will provide more clarity and consistency across DCTA system

### Major Changes to New Fare Media






- DCTA Local and Regional Passes no longer valid on GoZone unless customer is:
  - Reduced Fare Eligible
  - Nonprofit Pass Program member
  - Employer Pass Program member
- Paratransit customers ride all non-Access services for free with new ADA Badge
- "Children Under 5" pass to ride GoZone free
- No University Passes or UNT Student IDs are valid on GoZone
- Combined AM/PM Pass and Day Pass
- Eliminated separate Reduced Rare Pass
- All eligible fares clearly marked with GoZone logo

### How to Obtain Reduced Fare/ GoZone Eligible Fare






- Qualifying individuals are eligible to purchase DCTA passes that are valid for travel on GoZone.
- Passes valid on GoZone are easily identified by the GoZone Logo.
- Access Paratransit Customers
  - Paratransit Certified passengers may use their valid paratransit photo ID in lieu of DCTA Local/Regional Fare on GoZone services
- Reduced Fare Eligible Passengers
  - Passengers who qualify for reduced fares and hold a valid reduced fare eligible ID badge may purchase passes that are valid on GoZone.
  - · Reduced fare applications are available online or at the DDTC
- To qualify for reduced fare, a rider must be:
  - Seniors (65+)
  - · Persons with disabilities
  - Medicare cardholders
  - Students (ages 5 to 18; students over the age of 14 must have a valid high school or DCTA issued ID)





# Identifying Needs for Planning

- Notification
- Evacuation
- Emergency transportation
- Sheltering
- Access to medications, refrigeration, and back-up power
- Access to their mobility devices or service animals while in transit or at shelters
- Access to information



- Equal access to Emergency Shelters requires advance planning
  - Identify the disability-related needs of the residents and visitors likely to be housed in the shelter
  - Make the arrangements needed to meet those needs in advance of emergency or disaster events



- Ensure the sheltering program is accessible to people with disabilities.
  - Emergency shelter locations must be accessible by to all persons, including people with wheelchairs.
    - Parking, Access to Entrance, Toilets, Hygiene Facilities, Drinking Fountains, Sleeping Area, Food Distribution and Dining Quarters, First Aid/Medical Unit, Emergency Notification System, and other Activity and Recreation areas
    - Select facilities/sites that already provide this level of access or retrofit existing sites to do so
    - Guidance on emergency shelter accessibility, available from the Department of Justice's "ADA Checklist for Emergency Shelters" https://archive.ada.gov/pcatoolkit/chap7shelterchk.htm



- People with disabilities have the right to choose where to shelter
  - Shelters are usually divided into two categories: mass shelters for the general population, and "special needs" or "medical" shelters
  - People with disabilities should generally be housed in mass shelter locations
    - Communities may designate shelters for persons with disabilities, by cannot require people with disabilities or people with a specific type of disability to stay in such shelters



## Allow for Reasonable Modifications

- Change "No Pets" policies to welcome people who use service animals
  - Only two questions legally allowed to identify service animals:
    - "Do you need this animal because of a disability?"
    - "What tasks or work has the animal been trained to perform?"
- Modify kitchen access policies for people with medical conditions that may require access to food
- Modify sleeping arrangements to meet disability-related needs



## • Plan for multiple forms of Effective Communication

- Provide alternate formats for people who are blind or who have low vision
- Ensure that audible information is made accessible to people who are deaf or hard of hearing
- Provide a TTY (Teletypewriter) for use of people who are hard of hearing

# How do we use STEAR Information?

STEAR data can be utilized for all hazards such as: tornados, flood events, evacuations, wildfires, man-made emergencies, power outages, search and rescue, etc.

## • Planning:

Mapping: determining the proximity to known risk areas and identifying clusters versus isolated individuals or facilities.

Coordination: assess procedures for response operations, identify potential resource needs, identify resource availabilities and gaps, and develop contingencies.

• Preparedness:

Use STEAR during city/county full scale exercises.

## **BACKGROUND**

In November 2019, Voters approved a bond package that included 12 million for new sidewalk installation.

By implementing a master sidewalk work plan, the City is able to forecast projects based on anticipated bond funding. We can prioritize segments based on PPI score, design completion, roadway project completion timeline, reimbursable grant status, etc. as applicable. Utilizing the sidewalk bond funds responsibly with emphasis on priority areas

Since funding availability in 2020, The City has installed 27,115 LF of sidewalk/sidepath, of which 2,715 LF was designed in-house by our Capital Improvements Engineering team. Another 6,220 LF of sidewalk/sidepath is estimated to be installed in 2023. 3,570 LF of the 2023 total will have been designed in-house (thus far).

We currently estimate installing approximately 37,137 LF of sidewalk, sidepath or mixed-use path in the years 2024 and 2025. By the end of our 2019 Sidewalk Bond Fund issuances, the city estimates to have designed and constructed over 70,000 LF of pedestrian infrastructure.
