REGISTRATION GUIDELINES FOR ADDRESSING THE CITY COUNCIL

Individuals may speak during a Council meeting under one of the following categories:

Open Microphone:

At regular meetings only, individuals can speak on any topic that is not on the agenda for no longer than four (4) minutes per individual. This portion of the meeting occurs immediately after the start of the regular meeting session. Please note, Council members cannot engage in a discussion on topics presented during this portion and there are limited slots available for this portion of the meeting.

Comments on Agenda Items:

Public comments can be given for any item considered by the Council, EXCEPT work session reports or closed meetings. Individuals are only able to comment one time per agenda item and cannot use more than one method to comment on a single agenda item. Public comments are limited to three (3) minutes per citizen.

Public Hearing Items:

Individuals are limited to four (4) minutes per public hearing item.

Individuals may participate by using one of the following methods:

1. In Person for Regular or Consent Agenda Items:

To provide in-person comments regular or consent agenda items (excluding public hearing items), Individuals must be present at the meeting and submit a speaker card (available at the meeting location) to the City Secretary prior to the item being called.

2. In Person for Public Hearing Items:

For public hearing items, speaker cards are encouraged but not required.

3. eComment:

The agenda is posted online at <https://tx-denton.civicplus.com/242/Public-Meetings-Agendas>. Once the agenda is posted, a link to make virtual comments using the eComment module will be made available next to the meeting listing on the Upcoming Events Calendar. Using eComment, Individuals may indicate support or opposition and submit a brief comment about a specific agenda item. eComments may be submitted up until the start of the meeting at which time the ability to make an eComment will be closed. eComments will be sent directly to members of the City Council immediately upon submission and recorded by the City Secretary into the Minutes of the Meeting.

4. By Phone:

Individuals may register to provide comments by phone. Instructions and a link to register to comment by phone will be available at www.cityofdenton.com/publicmeetings until noon of the meeting date. Residents will submit contact information using the link provided and receive further instructions via email on how to join the meeting by phone and provide comments.

SUBJECT

Consider adoption of an ordinance of the City of Denton canvassing the returns and declaring the results of the Regular and Special Municipal Elections held on May 6, 2023; declaring that a runoff election is not necessary; and providing an effective date.

BACKGROUND

Adoption of this ordinance will formally canvass the election returns of the regular and special elections for council members in Districts 1, 2, 3, and 4, and Proposition A, held on May 6, 2023.

The Unofficial Results are attached as Exhibit A to the ordinance. These results show all successful candidates for District 1, District 2 (unopposed), District 3 and District 4 received a majority of the votes cast. As a result, a runoff election is not necessary. These results also show Proposition A received a majority of the votes cast. As a result, Council Member Jesse Davis shall be removed from the District 3 Seat of the City Council by Recall.

Monday, May 15, 2023, is the last day for the Early Voting Ballot Board to convene and qualify/count provisional ballots, overseas ballots, as well as mail in ballots postmarked by 5 p.m. on Monday, May 8. While minor revisions could result to the unofficial results reported on May 8, the outcome of the election is not anticipated to change. A revised ordinance/exhibit will be provided at (or shortly before) the meeting once received from Denton County Elections.

ORDINANCE NO. 23-323

AN ORDINANCE OF THE CITY OF DENTON CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE REGULAR AND SPECIAL MUNICIPAL ELECTIONS HELD ON MAY 6, 2023; DECLARING THAT A RUNOFF ELECTION IS NOT NECESSARY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Denton, Texas ("City") ordered a regular and special election to be held in the City on May 6, 2023 for the purpose of electing council members to Districts 1, 2, 3, and 4 and for the proposition of determining whether City Council Member Jesse Davis shall be removed from District 3 Seat of the City Council by Recall; and

WHEREAS, the election officers who held the election have duly made the returns of the result thereof, and these returns have been duly delivered to the City Council; and

WHEREAS, the meeting at which this ordinance was passed was open to the public, and public notice of the time, place, and purpose of said meeting was given, all as required by the Texas Government Code, Chapter 551. NOW THEREFORE;

THE CITY COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

SECTION 1. The City Council officially finds and determines the election held on May 6, 2023 was duly ordered, proper notice of this election was duly given, proper election officers were duly appointed prior to this election, this election was duly held, the City has complied with the Federal Voting Rights Act and the Texas Election Code, the returns of the result of this election have been made and delivered to the Council, and the City Council has duly canvassed these returns, all in accordance with the law and the ordinance calling this election.

SECTION 2. The official returns of the election, herein incorporated by reference and attached as "Exhibit A", having been opened, examined, and canvassed, and the Council hereby finds and declares that the following candidates received a majority of the votes cast at the election in Districts 1, 2, 3, and 4 and are declared to be elected to the City Council of the City of Denton as follows:

FOR DISTRICT 1:	VICKI BYRD
FOR DISTRICT 2:	BRIAN BECK (UNOPPOSED)
FOR DISTRICT 3:	PAUL MELTZER
FOR DISTRICT 4:	JOE HOLLAND

SECTION 3. The City Council finds and declares that no runoff election is necessary.

Election of a Mayor Pro Tem

Process

The following outlines the nomination/election process for the appointment of a Mayor Pro Tem.

- Mayor opens the floor to nominations for a Mayor Pro Tem.
 - Only after the Mayor announces, “*Nominations are now open*”, can members of the City Council make nominations.
 - If a member indicates a desire to nominate before the announcement, that member will not be acknowledged.
 - Council members must be acknowledged by the Mayor before voicing their nomination.
 - A council member may only make one nomination.
- Mayor shall accept as many nominations as members of the City Council may wish to submit.
 - The nominating council member may make comments to describe the reasoning for their nomination.
 - The Mayor will inquire of each nominee whether they accept the nomination.
- Mayor shall close the nomination process after verifying there are no more nominations received.
 - At this time, the floor shall be opened for commentary from any member of the City Council.
 - The item is opened for public comment, if any.
- Mayor shall put nominees to a voice vote in the order nomination(s) were submitted.
 - Once a nominee receives a simple majority vote of those members present, no other nominations will be considered.
 - In the event of a tie vote for any/all nominations received, the nominees previously submitted shall again be presented for election.
