REGISTRATION GUIDELINES FOR ADDRESSING THE CITY COUNCIL

Individuals may speak during a Council meeting under one of the following categories:

Open Microphone:

At regular meetings only, individuals can speak on any topic that is not on the agenda for no longer than four (4) minutes per individual. This portion of the meeting occurs immediately after the start of the regular meeting session. Please note, Council members cannot engage in a discussion on topics presented during this portion and there are limited slots available for this portion of the meeting.

Comments on Agenda Items:

Public comments can be given for any item considered by the Council, EXCEPT work session reports or closed meetings. Individuals are only able to comment one time per agenda item and cannot use more than one method to comment on a single agenda item. Public comments are limited to three (3) minutes per citizen.

Public Hearing Items:

Individuals are limited to four (4) minutes per public hearing item.

Individuals may participate by using one of the following methods:

1. In Person for Regular or Consent Agenda Items:

To provide in-person comments regular or consent agenda items (excluding public hearing items), Individuals must be present at the meeting and submit a speaker card (available at the meeting location) to the City Secretary prior to the item being called.

2. In Person for Public Hearing Items:

For public hearing items, speaker cards are encouraged but not required.

3. eComment:

The agenda is posted online at www.cityofdenton.com/publicmeetings. Once the agenda is posted, a link to make virtual comments using the eComment module will be made available next to the meeting listing on the Upcoming Events Calendar. Using eComment, Individuals may indicate support or opposition and submit a brief comment about a specific agenda item. eComments may be submitted up until the start of the meeting at which time the ability to make an eComment will be closed. eComments will be sent directly to members of the City Council immediately upon submission and recorded by the City Secretary into the Minutes of the Meeting.

4. By Phone:

Individuals may register to provide comments by phone. Instructions and a link to register to comment by phone will be available at www.cityofdenton.com/publicmeetings until noon of the meeting date. Residents will submit contact information using the link provided and receive further instructions via email on how to join the meeting by phone and provide comments.

BACKGROUND

Adoption of this ordinance will formally canvass the election returns of the regular election for council members in Places 5, 6 and a Mayor to Place 7 held on May 4, 2024.

The Unofficial Results are attached as Exhibit A to the ordinance. These results show all candidates received a majority of the votes cast. As a result, a runoff election is not necessary.

Monday, May 13, 2024, is the last day for the Early Voting Ballot Board to convene and qualify/count provisional ballots, overseas ballots, as well as mail in ballots postmarked by 5 p.m. on Thursday, May 6, 2024. While minor revisions could result to the unofficial results reported on May 7, 2024, the outcome of the election is not anticipated to change. A revised presentation will be provided once the official results are received from Denton County Elections.

ORDINANCE NO. 24-910

AN ORDINANCE OF THE CITY OF DENTON CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE REGULAR MUNICIPAL ELECTION TO ELECT THREE CITY COUNCIL MEMBERS TO PLACES 5, 6, AND A MAYOR TO PLACE 7 OF THE CITY COUNCIL OF THE CITY OF DENTON, HELD ON MAY 4, 2024; DECLARING THAT A RUNOFF ELECTION IS NOT NECESSARY; AND PROVIDING AN EFFECTIVE DATE.

WHEREAS a regular municipal election of the City of Denton was held on May 4, 2024, to elect Council Members to Places 5, 6 and a Mayor to Place 7; and

WHEREAS, the official returns of the election have been opened, examined and canvassed; NOW THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

<u>SECTION 1</u>. The City Council finds and declares that the May 4, 2024 regular municipal election was duly ordered for the purpose of electing council members to Places 5 and 6 and a Mayor to Place 7; proper notice of said election was duly given and election officials appointed; the election was duly held and the returns of the election officials have been delivered to the Council, all in accordance with the laws of the State of Texas and the Charter and ordinances of the City of Denton.

<u>SECTION 2</u>. The official returns of the election, herein incorporated by reference and attached as "Exhibit A", having been opened, examined, and canvassed, and the Council hereby finds and declares the following candidates received a majority of the votes cast at the election in Place 5, 6, and 7 and are declared to be elected to the City Council of the City of Denton as follows:

FOR PLACE 5:	Brandon Chase McGee
FOR PLACE 6:	Jill Jester
FOR PLACE 7 (Mayor):	Gerard Hudspeth

and the candidates shall assume the duties of office on the date they take the official oath of office.

<u>SECTION 3</u>. The City Council finds and declares all candidates received a majority of the votes cast and runoff election is not necessary.

<u>SECTION 4</u>. The City Council has found and determined the meeting at which this ordinance is considered is open to the public and that notice thereof was given in accordance with provisions of the Texas open meetings law, Texas Government Code Chapter 551, as amended, and that a quorum of the City Council was present.

SECTION 5. This ordinance shall become effective immediately upon its passage and approval.
