





Budget FY 25 - Animal Care Technicians (2 FTEs)

Current Situation:

- Pulling ACO2 from the field to cover gaps
- Have tried modifying schedule to address pain points
- No backups when staff are sick or on vacation
- Adoptable Areas must be ready by 10am
- Daily average of animals in care is 116
- FY 23 intake 5,303- up 12% from FY 22
- 76.8 FTE hours/ day required to provide care or 13.47 FTEs annually
- Current shelter staffing level is 11.5 FTEs
- Need an additional 2 FTEs to meet appropriate staffing levels to provide care
- **\$143,738 Fiscal Impact**

Budget FY 25 - Behavior, Enrichment, & Placement Coordinator (1 FTE)

Behavior Assessment Needs / Placement

- Took in 2,626 dogs in FY 23 = average of 7 behavior assessments needed to complete each day
- At 1 hour to conduct, that is 7 FTE hours/day or 2,555 hours/year
- Currently, behavior assessments are conducted on an ad hoc basis as staff time allows and on Wednesdays

Intake Diversion

- 1,010 animals surrendered to the shelter in FY 23
- 178 returned adoptions in FY 23
- Current owner surrender waitlist is 86 animals long
- Create better matches for adoptions by providing more thorough animal information to adopters
- Assist in problem-solving through owner education and training tips for problem behaviors

Length of Stay (LOS)


- Average LOS for dogs at shelter who are adopted is 11.9 days
- Average LOS for dogs that result in euthanasia due to medical or behavioral issues is 37.8 days
- Enrichment programs that incorporate behavior training have been shown to improve adoptability.
- Cost for FTE \$89,123







Targeted Community Outreach

- Uptick in raccoon Distemper cases near Idiot's Hill area
- Unhoused pet population at greatest risk due to high exposure possibility and lack of vaccination
- Free vaccination clinic to target this group hosted 5/15 at ODB
- 13 animals served (11 dogs, 1 cat, 1 rabbit)








Mandatory Microchipping Chapter 6

- Includes implanting on intake






Volunteer Program

- On June 1, Animal Services began tracking all volunteer hours through Galaxy Digital.
- Opportunities are being added based on the current needs of the shelter.
- In June, volunteers contributed 406.49 hours to the shelter.
- A new volunteer orientation was conducted on June 15, with 38 attendees.
- In collaboration with Marketing & Communications, five short training videos were filmed. The videos will be used as a resource for new & current volunteers.
