### **BACKGROUND**

In July 2023, Mary J. Kayser, TRMC with City Hall Essentials conducted a review of the City Secretary's Office operations. The five key areas analyzed were Meeting Management, Public Information, Records Management, Boards and Commissions, and Elections. One of the recommendations stemming from this review pertained to the online Vote Record. The consultant observed that the Vote Record site appeared redundant, as voting records were already meticulously documented within meeting minutes, ordinances, and resolutions. Furthermore, the City Charter stipulates that votes be recorded solely within the minutes. Consequently, the decision was made by staff to discontinue the regular updates to the Vote Record webpage.
