Called to order 12:02 p.m. by Vice Chair Drew Christ with six members present. Member Conner had not yet arrived.

1. ITEMS FOR INDIVIDUAL CONSIDERATION

A. CSAC 24-016 - Consider approval of the minutes of April 12, 2024.

Vice Chair Drew Christ requested a motion to approve the April minutes.

Member Tampke moved to approve the minutes. Member Prado-Carillo seconded the motion. The motion carried.

The funding application for the 2024-25 Street Outreach Grant opened Friday, May 31, and closed Friday, June 28. A notice of funding opportunity was distributed via Community Services' Constant Contact email list, the City's social media accounts and in the Friday Report to City Council. Three (3) applications were received from Denton County MHMR, Giving Grace, and Metro Relief.

Staff reviewed and scored applications based on the scoring rubric included in the application. Scoring was provided to the committee. Applicants were invited to make a five (5) minute presentation to the committee at the July meeting, and committee members had an additional five minutes to ask presenters questions.

Following presentations, committee members deliberated and discussed applications.

Member Tampke moved to fully fund Giving Grace for the 2024-25 and 2025-26 Program Years. Member Prado-Carillo seconded.



Who needs housing?



Housing is a crucial need for everyone, regardless of income or economic status. In Denton, the households who struggle the most to afford housing are low income.

What does low income mean?

Housing in the U.S.A. looks at income through the lens of area median household income. The area median household income is the median amount households make in our region. By considering what households look like when they make 30%, 50%, or 80% of this median income, we can understand Denton's housing needs better.

What does Low Income mean?



Jessica raised her children and now is helping to raise her grandchildren in Denton. She worked hard her whole life and retired at sixty-seven. Her social security income is 30% of the area median income. She is considered Extremely Low Income.



Candace is a childcare worker in Denton. Her work is important to Denton's economy, and she loves doing it. Her wages are 50% of the area median income. She is considered Very Low Income.



Gregory is an elementary school teacher in Denton. He loves working in his own community and making an impact where he lives. His salary is 80% of the area median income. He is considered Low Income.

What does Low Income mean?

All of these households are considered low income, and struggle to afford adequate housing in Denton, even though they love living here. In Denton, approximately 48% of households live on incomes like Jessica, Candace and Gregory's.



Extremely Low Income: 16% of Denton households, or 8,300 households, are extremely low income, like Jessica.



Very Low Income: 14% of all Denton households, or 7,300 households, are Very Low Income, like Candace.




Low Income: 18% of all Denton households, or 9,400 households, are Low Income, like Gregory.

What makes housing affordable?

If someone low income like Jessica, Candace, or Gregory can live in a home and spend only 30% of their income on housing, then it is considered affordable.

In simpler terms, approximately a third of what they bring in each month goes to their rent or mortgage, while the rest can go to food, healthcare, and other things they need.

Cost Burden

When a household is spending more than 30% of their income on housing, they are considered Cost Burdened. Some households spend more than 50%, or half, of their income on housing each month, meaning they are **Severely Cost Burdened.**



- 31% are Cost Burdened
- 38% or Severely Cost Burdened



Severely Cost **Burdened** 38% Cost Burdened 31%

Of Extremely Low-Income households like Jessica, 88% are severelý cost burdened.

Infill Development leverages empty spaces within existing areas for new housing development. It introduces diverse and affordable housing types to established neighborhoods.

Key Actions:



- Infill Amendments: Amend the Denton Development Code to allow Townhomes, Duplexes, and Cottage Courts in more neighborhoods.
- Accessory Dwelling Unit (ADU) Program: Enhance the existing ADU program, meaning slight adjustments to the Denton Development Code, as well as pre-approved design plans to simplify processes for interested homeowners.

- Incentive Variances: Amend the Denton Development Code to implement incentive variances that include: Reduced parking requirements, Increased density allowances, flexible building types and setbacks
- Overlay Districts: Establish special zones called Overlay Districts with flexible zoning regulations designed to promote the development of affordable housing.

Investing in Housing means committing City resources towards housing, just like it invests in economic development, arts, or infrastructure. To leverage these resources as effectively as possible, the City collaborates with other stakeholders such as housing authorities, non-profits, and private developers to maximize outcomes.

- Capacity Support: Financially support non-profit developers to enhance their ability to create housing.
- Development Financing: Establish a revolving door, low-interest loan program for development. This will help cover initial project costs or gap financing. In exchange, developments will set aside homes for low income households.

- Housing Fund: Establish long-term funding mechanisms, such as a housing trust fund, or housing finance corporation, for sustainably funded housing programs.
- Land Acquisition: Utilize land banking and community land trusts to acquire and hold land for future housing development and to preserve existing affordable homes for the future.

- Rental Rehab: Provide funding for landlords to maintain and improve affordable rental properties in exchange for affordable rents.
- Homebuyer Assistance: Offer financial assistance to low income homebuyers for down payments and closing costs. Create a special funding pot for Housing Choice Voucher holders to transition to homeownership and collaborate with major employers to fund employer-based assistance programs.






