


BACKGROUND

The GreenSense program changes implemented for Fiscal Year 2024, (FY24) have been incredibly well received. As of May 31, 2024, staff has processed, 661 Applications and approved, 520 applications for rebates totaling \$637,208. Fans have been purchased for the annual giveaway and funds are encumbered for the Audit Program and Multifamily and Residential Conservation Kits.

<u>Expenditures for the GreenSense Program</u>	
GreenSense Rebates	\$637,208
Annual Fan Giveaway	<u>\$34,330</u>
Audit program	\$10,000
Multifamily Kits	<u>\$6,000</u>

Total Expended \$687,538

Remaining \$312,462

Electric Vehicle and Electric Bike Rebates have depleted adjusted budget amounts and are on currently on hold pending available funding.

Staff will provide monthly GreenSense updates to the Committee, and if necessary, funding will be adjusted between categories as funding is depleted.

A revised GreenSense Manual will be presented at the next Committee meeting for review.

Background

- GreenSense Program began in 2009
- Prior to FY24 update the program incentive levels had been in place since FY 18
- Program is administered by Environmental Services and Sustainability and funded through DME (only DME customers are accepted)
- Energy efficiency focused on heating and cooling (HVAC, Insulation, Smart Thermostat, etc.)
- Funding of \$1,000,000 approved for FY24 GreenSense program
