BACKGROUND

Ordinance 19-2865 (**Exhibit 2**) was adopted by City Council on January 28, 2020 and amended Section 2-29(h) of the Denton City Code to require Boards, Commissions, and Committees adopt a regular meeting schedule each year.

The requirement can be found in Section 2-29(h)(4)(c) and reads as follows:

Unless otherwise provided by law, each board, commission, or committee, shall adopt a regular meeting schedule by no later than the body's first meeting of the calendar year. All regular meeting schedules shall be sent to the City Secretary's Office for official record keeping purposes upon adoption. Regular meeting schedules should include all planned meetings the body intends to have during the calendar year.

The amendment was effective immediately upon its adoption. Therefore, the Public Art Committee needs to proceed with adopting its meeting schedule for year 2023. The proposed schedule is attached as **Exhibit 3**.

Because it is understood that the start time and meeting location can vary based on room availability, that information is not included as part of the proposed schedule. The requirement for an annual schedule was to clearly define the day/month. If at any point in time a meeting cannot/will not be held, a cancellation notice will be duly posted in coordination with the City Secretary's Office. There will be no need to amend the meeting schedule should a meeting have to be canceled.

Prepared by: Caroline Seward, Business Administration Manager Parks and Recreation AN ORDINANCE OF THE CITY OF DENTON AMENDING THE CITY OF DENTON CODE OF ORDINANCES (CODE) SECTION 2-29 (CITY COUNCIL RULES OF PROCEDURE) SUBSECTION (H) (CREATION OF COMMITTEES, BOARDS, AND COMMISSIONS) REQUIRING BOARDS, COMMISSIONS, AND COMMITTEES TO ESTABLISH A REGULAR MEETING SCHEDULE; PROVIDING FOR A SEVERABILITY CLAUSE; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Denton creates various boards, commissions, and committees to participate in the City's governmental process, and give input on topics of community importance; and

WHEREAS, the City Council recognizes that board, commission, and committee membership is a significant time commitment for Denton residents; and

WHEREAS, the City Council desires to help members of boards, commissions, and committees better understand the time commitment and meeting schedule of their respective seat by requiring the adoption of regular meeting schedules annually; and

WHEREAS, Denton City Council meetings are conducted in accordance with the Council Rules of Procedure set forth in Section 2-29 of the Denton City Code of Ordinances; NOW THEREFORE,

THE COUNCIL OF THE CITY OF DENTON HEREBY ORDAINS:

SECTION 1. That Section 2-29 (h) of the Denton Code of Ordinances, known as the Denton City Council Rules of Procedure, is hereby amended to read as follows:

- (h) Creation of committees, boards and commissions.
 - (1) Council committees: The council may, by resolution and as the need arises, authorize the appointment of council committees. Any committee so created shall cease to exist when abolished by resolution of the council. Council committees shall comply with the Texas Open Meetings Act.
 - (2) Citizen boards, commissions, and committees: The council may create other citizen boards, commissions, and committees to assist in the conduct of the operation of the city government with such duties as the council may specify not inconsistent with the City Charter or Code. Creation of such boards, commissions, and committees and memberships and selection of members shall be by council resolution if not otherwise specified by the City Charter or Code. Any board, commission, or committee so created shall cease to exist when abolished by a resolution approved by the council. No committee so appointed shall have powers other than advisory to the council or to the city manager, except as otherwise specified by the Charter or Code. All citizen boards, commissions, and committees shall comply with the procedural requirements of the Texas Open Meetings Act. Any reference in this article to "citizen boards, commissions,

and committees" includes citizen task forces and citizen ad hoc boards, commissions, and committees unless otherwise indicated herein.

(3) Appointments:

- a. Individual city council members making nominations for members to citizen boards, commissions, and committees will consider interested persons on a citywide basis.
- b. The city council will make an effort to be inclusive of all segments of the community in the board, commission, and committee appointment process. City council members will consider ethnicity, gender, socio-economic levels, and other factors to ensure a diverse representation of Denton citizens.
- c. The city council will take into consideration an individual's qualifications, willingness to serve, and application information in selecting nominations for membership to each board, commission, and committee.
- d. In an effort to ensure maximum citizen participation, city council members will continue the general practice of nominating new citizens to replace board members who have served three (3) consecutive terms on the same board per the provisions of Denton Code of Ordinances, section 2-65. This provision does not apply to citizen task forces and citizen ad hoc committees.
- e. Each city council member will be responsible for making nominations for board, committee, and commission places assigned to him or her, which shall correspond to the city council member's place. Individual city council members will make nominations to the full city council for the governing body's approval or disapproval.

(4) Rules of procedure:

- a. All board, commission, and committee members, including citizen board, commission, and committee members, shall comply with the provisions of article II of chapter 2 of the Code of Ordinances. All board, commission and committee members, including citizen board, commission, and committee members, shall be provided a copy of these rules of procedure and a copy of the City of Denton Handbook for Boards, Commissions and Committees, which shall govern operational procedures of all boards, commissions and committees, including citizen boards, commissions, and committees, including citizen boards, commissions and committees, shall comply with these rules as to the preparation of minutes of meetings, and such minutes shall be prepared in accordance with the policies and procedures of the city secretary.
- b. All citizen board, commission, and committee members shall comply with the procedural requirements of the V.T.C.A., Texas Government Code Chapter 551, also known as the "Texas Open Meetings Act" as they appear now or may be amended in the future. Notice of all meetings shall be posted in compliance with the Texas Open Meetings Act and minutes and records will be maintained in accordance with requirements of the city secretary's office. Each citizen board, commission, and committee member shall be provided a copy of the Texas Open Meetings Act. Penalty provisions of the Texas Open Meetings Act shall only

apply to citizen boards, commissions, and committees with rule making or quasijudicial power, as set forth in the Texas Open Meetings Act and as interpreted by Texas Courts.

c. Unless otherwise provided by law, each board, commission, or committee, shall adopt a regular meeting schedule by no later than the body's first meeting of the calendar year. All regular meeting schedules shall be sent to the City Secretary's Office for official record keeping purposes upon adoption. Regular meeting schedules should include all planned meetings the body intends to have during the calendar year.

SECTION 2. The provisions of this Ordinance are severable, and the invalidity of any phrase, clause, or part of the Ordinance shall not affect the validity or effectiveness of the remainder of the Ordinance.

SECTION 3. This ordinance shall become effective immediately upon its passage and approval.

BACKGROUND

This item is to gather feedback and provide updates on the ongoing, new, and proposed public art projects.

Ongoing Projects

Tennis Center

The public art project located at the Tennis Center has a budget of \$36,000 comprised of bond funds. At the request of the Public Art Committee (PAC), individuals from Denton Area Tennis Association and the tennis pros at the Goldfield Tennis Center were contacted for thematic input. Input was received from Luis Valdez from the Denton Area Tennis Association. His input was that the artwork should show tennis as an inclusive sport and that the work should be inspirational was used as the art theme in the scope of work.

An artist call was completed on June 30, 2022. Proposals were received from two artists. The PAC subcommittee and tennis center staff reviewed and scored the proposals. The leading proposal by artist Christine Sanders was approved by the PAC in the August 4, 2022, meeting at a cost of \$35,353.26. The artist has been given the notice to proceed with the final designs on the racquets.

Subcommittee assignments are Franklin, Nichelson, and Chamberlin.

Bell Avenue & Wainwright Street Sculpture (Formerly Dallas Drive and Teasley Sculpture)

The public art project was formerly to be located on Dallas Drive and Teasley Lane. The PAC provided input in their April 2022 meeting that the Bell Avenue and Wainwright Street was a better location. While determining the location, PAC expressed interest in Eagle Drive and Elm, however staff did not recommend the site for placement of Public Art, due to visual obstructions. This project has a budget of \$25,000

comprised of bond funds dedicated to transportation projects. Some issues have been noted with using the Bell & Wainwright location due to traffic visibility and the proximity to the Bell Avenue railroad overpass mural. The proposed relocation is identified at S. Bonnie Brae Street close to Vintage Blvd.

Subcommittee assignments are Nichelson and Nuchols. The other subcommittee members have rotated off the PAC.

Bonnie Brae Roundabout Sculpture

The public art project located at the Bonnie Brae Roundabout has a budget of \$133,020 with \$50,000 artist budget and \$83,020 for site improvements. A call for artists was conducted in December 2021. Three proposals were received and evaluated. The PAC accepted the proposal of "Dog Star" by artist Elizabeth Akamatsu in the February 10, 2022, meeting. City Council approved the contract (7-0) on February 15, 2022. The artist completed the design and was given the notice to proceed with the fabrication. The sculpture was installed on September 3, 2022. The landscaping and irrigation have been installed and lighting will be completed by December.

Subcommittee assignments are Lane, Liechty, and Nuchols.

Traffic Box Wraps in the ODD

The PAC indicated its interest in creating a pilot program to wrap utility boxes in 2019. Two skins for traffic boxes were created at the 2019 Arts and Jazz Festival and installed at two locations in the Original Denton District (ODD) cultural arts district. This project will expand the program to wrap the rest of the traffic boxes in the ODD. This would include the area in the ODD, the roads forming the border of the ODD, and cover up to 18 boxes. A grant application was submitted to the Texas Commission on the Arts (TCA) in July 2022, for \$12,000 to cover half of the estimated \$24,000 needed to prepare and wrap the boxes. Staff was notified in September that the grant award would be half the requested amount of \$6,000. The matching portion of this grant will come from the 2022-2023 HOT Funds allocation. The wrap designs will come from involvement with our UNT, TWU, and DISD partners and through a local artist call. Suggested themes for the art include Historic Denton, Science, Nature, Music Denton, and Denton Diversity. This project was reviewed by the Traffic Safety Commission on July 18, 2022 and received many supportive comments. Artist calls have been made to the Denton Independent School District (DISD) high schools and to art program coordinators at Texas Woman's University and the University of North Texas. The artist's call for the DISD schools was due on November 18.

A subcommittee has not been assigned to this project.

ART REPAIR & RENOVATION

National Humane Alliance Fountain

The National Humane Alliance fountains are a series of granite drinking fountains distributed by the National Humane Alliance in the early 1900s. Up to 125 fountains were donated to cities in both the United States and Mexico. They were intended to provide fresh drinking water for horses, dogs, and people. Denton received one of the fountains that was originally located near the courthouse on the square. The fountain is currently located next to the Women's Club building in Quakertown Park. The fountain's base and upper portion are still in good shape. However, sometime in the past the brass lion head features were removed, piping was cut out, and cement filled into some of the fountain spaces. Renovation of the fountain will include reproducing the lion heads, removing the cement, and replumbing. The renovated fountain will then be relocated to a site yet to be determined, possibly within Quakertown Park.

Bell & Sherman Mural Repair

This mural, also known as the KDB Flower Mural, is showing some weathering and pealing. The mural will need to be cleaned, damage repaired, and a fresh coat of preservative to prevent damage from vandalism. Costs to be determined.

Sycamore Bridge Mural Renovation/Replacement

The mural on the bridge guardrail is weathered and has existing damage from past vandalism. Staff will be meeting with residents of the community and members of the Southeast Denton Neighborhood Association whether they would like the mural renovated, removed, or a new mural in its place.

POSSIBLE FUTURE PROJECT

Downtown Murals in Alleys and Backsides of Buildings

The Denton Main Street Association (DMSA) is proposing a partnership with the PAC. The DMSA asked the question, "Can DMSA start to work with Public Arts Committee and Parks & Recreation staff to begin some mural and beautification efforts on back-streets and alleys?" One proposed location that is being discussed is the alley between 116 and 120 Austin Street.

ESTIMATED SCHEDULE OF PROJECTS

The Tennis Center sculpture is expected to be completed by December 2022. The Bell Ave. & Wainwright sculpture is projected to be completed by Fall 2023. The Bonnie Brae roundabout project was completed on September 3, 2022. The Traffic Box Wraps in the ODD will be completed in phases throughout the year with the first installations in early spring. The National Humane Alliance Fountain is expected to be completed by summer, 2023. The Sycamore bridge mural completion will be started once staff has received community input.

OPERATIONAL IMPACT

Each project will have an anticipated maintenance need. A supplemental request will be submitted the following fiscal year to offset anticipated maintenance expenses.

FISCAL INFORMATION

- 1. Tennis Center (Project #400276), \$36,000 budget. No funds have been spent on this project.
- 2. Bell Avenue & Wainwright Street Sculpture (Project #450013467), \$25,000 budget.
- 3. Bonnie Brae Roundabout Sculpture (Project #450008) \$133,020 budget (\$50,000 artist budget and \$83,020 site improvements). Funding for this project came from \$54,010 Hotel Occupancy Tax and \$79,010 bonds.
- 4. Traffic Box Wraps (no project number assigned) projected budget \$12,000 (\$6,000 TCA grant and \$6,000 Hotel Occupancy Tax funds)
- 5. Art Renovation & Repair Project numbers and budgets will be assigned after full assessments of the artwork has been completed and estimates received from original artists or restoration specialists.
- 6. Downtown Murals in Alleys No funding has been currently identified.



BACKGROUND

In June 2019, the City approved support to seek state designation as an official cultural district from the Texas Commission on the Arts via resolution 19-1158. In addition, Chapter 22 of the City's Code of Ordinances was amended to provide the Public Art Committee (PAC) oversight to make recommendations to the Council related to cultural districts via ordinance 19-1156.

Cultural districts are defined geographical areas which encourage and celebrate arts, culture, entertainment, and history for the purpose of economic and community development. They are formed around existing concentrations of "cultural assets" clustered in a walkable area that a city wants to promote to visitors and residents. Cultural assets include performances and exhibitions, creative activities, architecture, and historical offerings. Cultural districts do not obligate property owners to any type of additional regulations. For cities, cultural districts exist as locally designated districts.

A Texas Commission on the Arts (TCA) Cultural District is primarily used as a marketing point for local communities. Grant funding from TCA can be used for cultural tourism projects subject to funding availability. TCA Cultural Districts must submit an annual report to TCA and must be recertified every 10 years.

In reference to the naming of the Original Denton District or ODD, the word "original" can mean first or earliest. It also can mean unusual or eccentric – maybe even odd. Denton has a wealth of cultural assets, and the ODD is a way to showcase those assets for economic development and cultural tourism, open up new avenues for grant funding, and support arts and culture. The ODD is centered in Downtown Denton and includes a large part of Southeast Denton.

- 1. Report back from the addition of an "Amplify" like site to the ODD website or at the Denton Library website.
- 2. Report results of the Texas Commission on the Arts grant application.



BACKGROUND

O'Neil Ford, the architect that designed City Hall, Emily Fowler Library, the Civic Center, and structures around the Civic Center Pool. As a part of the designs, he specified lighting fixtures by the Beaumont Mood Lighting Company.

Staff is researching ways to replace or repair damaged or missing fixtures. Staff is also exploring using volunteer help, in partnership with the Denton Public Library, to clean the exterior fixtures. Staff contacted the Ford Powell Carson Architects (FPC) for information about the fixtures and how they can be repaired, replaced, and maintained. Alayna Jordan, Preservation Specialist with FPC, spent six hours with staff over two days to assess the condition of the existing fixtures and to provide a short in-service on how to clean them.

During the FPC visit, they noted that the O'Neil Ford Civic Complex had approximately 191 fixtures. The approximate number was given because some of the exterior building lighting fixtures are missing from their mounts. She noted that 150 fixtures are in need of cleaning while up to 64 fixtures needed cracks repaired and/or missing pieces replaced.

FPC offered a proposal for training staff on the proper cleaning methods. The cost for the training was quoted as \$3,000 plus reimbursable expenses. FPC also offered a full-service conservation option that is estimated to take up to four weeks. In this option they would provide cleaning and repair of all installed Mood fixtures. This option would not replace lost fixtures or repair fully broken fixtures that are missing pieces. The full-service option is listed at \$33,500 plus reimbursable expenses.

A subcommittee has not been assigned to this project.

RECOMMENDATION

N/A

ESTIMATED SCHEDULE OF PROJECT

The cleaning of the fixtures can start once volunteers have been recruited and trained. Funding will need to be identified for the restoration/replacement of fixtures before this can be scheduled.

OPERATIONAL IMPACT

The public art repair budget will need to be increased in FY 2023-2024 to purchase cleaning supplies and materials.

FISCAL INFORMATION

A portion of the public art maintenance budget can be used for an initial purchase of approximately \$500 for cleaning supplies.

The Quakertown Beaumont Mood survey with park management staff, John Whitmore and Chris Escoto, resulted in the documentation and the location of over 191 Beaumont Mood fixtures. Approximately 150 are due for cleaning, 26 with cracked surfaces, and 40 with advanced cracking, damage, and/or missing pieces. Moods in City Hall and the Senior Center were documented to be in good condition based on maintenance and the recent restoration in 2015. Moods with severe damage were found at the Municipal Swimming Pool and Civic Center. Approximately a dozen Moods were used for alternative purposes, such as display items, planters, and storage containers. There are upwards of ten Moods in storage owned by the City of Denton at an off-site location.

- Prepare a conservation treatment report and relocation plan for the fixtures within the Civic Center, Emily Fowler Library, Municipal Swimming Pool, and City Hall.

BASIC SERVICES

We propose two conservation service options, as discussed with John Whitmore on July 15, 2022. One or both options can be provided as a basic service:




