SUBJECT

Consider recommending the City Council adopt an ordinance of the City of Denton authorizing the City Manager or his designee to execute a contract through the National IPA Purchasing Network for the acquisition of one (1) 2014 CAT model MH3037 material handler for the City of Denton Solid Waste Department; and providing an effective date (File 6224-awarded to Holt CAT in the amount of \$455,584.49).

BACKGROUND

This item is an addition for the Solid Waste Department and will be used as part of their upcoming mining operation. The unit that staff is recommending is a demo model with 800 hours currently. The equipment will have the same warranty as a new unit and will be fully serviced by the vendor prior to the City of Denton accepting delivery. Staff is recommending the purchase of the demo equipment due to the \$83,349.75 savings over the newer CAT model and \$62,060.38 less than the next low bid. The equipment is also immediately available so there will be no order lead time. The material handler will be purchased through the National IPA Cooperative Purchasing Network Contract# 120377.

Quotes were obtained from three (3) cooperative contract vendors. Bids on demo models with up to 1,000 hours were requested but Holt CAT was the only vendor with a demo unit that met specifications (Exhibit 2).

RECOMMENDATION
