BACKGROUND

The proposed FY 2016-2017 Electric utility rates were presented and approved by the PUB on July 25, 2016. The proposed electric rate ordinance included in this agenda item is designed to recover the cost of service for the Electric utility and provide a positive or break-even net income.

The average residential customer using 1,000 kilowatt hours would incur the following monthly charge.

Current	Proposed	Increase
\$115.75	\$116.20	\$.45
