Consider a recommendation for CP&Y, Dallas, Texas, to provide professional services to assist the City of Denton Solid Waste & Recycling Department with development, design, and construction related services for Departmental capital construction projects, in the amount of \$90,000. (PSA 6381)

BACKGROUND

The Solid Waste & Recycling Department staff is seeking professional engineering and administrative services from the CP&Y consulting staff related to various landfill construction projects planned for the upcoming year. Their staff will be utilized to provide professional services and support for the construction of the ECO - W.E.R.C.S. site entry road and associated improvements within that area related to the road construction project. Their services will also be utilized to provide plan documents for various improvements to the infrastructure of the landfill site, drainage basins, retaining walls, and internal construction projects as determined on an as needed basis throughout the year.

CP&Y will be available to provide any needed modifications to the Municipal Solid Waste permit on file with the Texas Commission on Environmental Quality.
